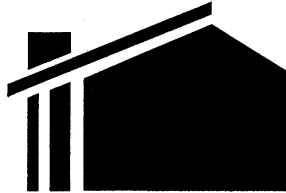


# 2011 Parade of Homes Builder Participation Agreement and Registration Form

### GENERAL INFORMATION

1. Dates: Saturday, September 17, 10:00AM - 5:00PM  
Sunday, September 18, 12:00PM - 5:00PM
2. Parade members must be Builder Members in good standing of WCNHBA.
3. Builders may enter as many homes, condos, duplexes, etc. as they wish.
4. Participants will be charged \$300 per entry. Builder must be registered and entry fee must be paid by **July 30, 2011** to be eligible. Registrations received after July 30 will be charged \$400. No entries accepted after **August 5, 2011**
5. Entry fees are non-refundable
6. Builder may not enter an occupied home in the Parade without written permission and liability waiver signed by the owners
7. The WCNHBA will not be responsible for any loss, injury or damage that may occur to your entry during the parade. It is a provision of the contract that all Builders participating in this Parade have public and property liability insurance to protect themselves and the WCNHBA against possible claims rising out of any negligent acts during the Parade of Homes.
8. All homes will need to pass a pre-Parade Inspection to ensure home is safe and ready for the general public.
9. It is the builders responsibility to make sure his home is managed at all times and days during the parade. If help is needed please contact a committee member.

### ENTRY INFORMATION

#### EXTERIOR

1. All concrete must be in place
2. Yard must be rough graded (grass and shrubs not required)
3. All decks must be completed and pass local Building Codes
4. Exterior of house must be 100% completed.
5. Home sites must be cleaned of trash and all other materials that are not part of the completed project

#### INTERIOR

1. All electrical must be completed and in compliance with local codes.
2. All sheetrock must be installed.
3. Cabinets and trim packages must be in place.
4. Countertops and floor coverings do not have to be installed.
5. All handrails must be in place and meet local building codes.

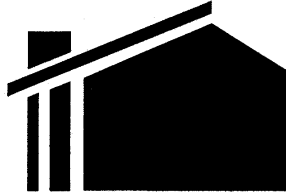

2. Remodeler members must be Builder Members in good standing of WCNHBA.
3. Builders may enter as many **"completed remodeling"** projects as they wish.
4. Participants will be charged \$150 per entry. Builder must be registered and entry fee must be paid by **July 30, 2011** to be eligible. Registrations received after July 30 will be charged \$200. No entries accepted after **August 5, 2011**
5. Entry fees are non-refundable
6. Builder may not enter an occupied home in the Tour without written permission and liability waiver signed by the owners
7. The WCNHBA will not be responsible for any loss, injury or damage that may occur to your entry during the Tour. It is a provision of the contract that all Builders participating in this Tour have public and property liability insurance to protect themselves and the WCNHBA against possible claims rising out of any negligent acts during the Tour of Remodeled Homes.
8. All homes will need to pass a pre-remodeled inspection to ensure home is safe and ready for the general public.
